- (If applicable) a **borrowed time letter**, granting permission to use the businesses allotment of Temporary Sign Permit time.
- A **cheque in the amount of \$150.00** made payable to the Town of Whitby for the cost of the permit.

**Application fee is non-refundable.** (One payment per application)

**Please note that incomplete applications will not be accepted by the By-law Division.**

#### Sight Triangles (please review)

Please note that temporary mobile signs are not permitted to be located within a sight triangle. Sight triangles are typically located near roadway intersections and are in place to protect the sight lines of motorists and pedestrians. Listed below, please find the dimensions of the sight triangles throughout the Town:

Zoning By-law 1784:	12.0 metres
Zoning By-law 2585:	9.0 metres
Downtown Whitby Zoning By-law:	4.5 metres
Downtown Brooklin Zoning By-law:	4.5 metres
