

MOVIES IN THE PARK “VIP SEATS” CONTEST PRIZE DECLARATION AND RELEASE

The Movies in the Park “VIP Seats” Contest (the “**Contest**”) is presented and administrated by The Corporation of the Town of Whitby (the “**Town**”).

1. I do hereby state and declare that I, _____, of the _____, am the selected entrant in the Contest.

2. I understand that I will be declared one (1) of one (1) random winners and awarded the prize consisting of one (1) of one (1) “VIP Seats and all the Treats” certificate (the “**Certificate**”) to attend any one (1) of the July 29 (Encanto), August 12 (Flashback Friday – The Goonies) or August 26 (Spiderman; Far from Home) movie presentation at Whitby Civic Park. The Certificate entitles the winner to the use of four (4) comfortable front row seats, blankets, popcorn, snacks, treats and refreshments (approximate retail value: \$75.00 CDN) (the “**Prize**”) if I return this completed Declaration and Release to be received by the Town at least seven (7) business days from the date of notification by the Town or on a mutually agreed upon date, and otherwise comply with the Contest rules.

3. In consideration of the Prize that will be awarded to me, I hereby:

- (a) acknowledge that the Prize is as described in the Contest rules, a copy of which is attached to this Declaration and Release;
- (b) agree that I will accept the Prize as awarded, and its receipt by me shall fully discharge and release The Corporation of the Town of Whitby, its affiliates, advertising and promotional agencies, the suppliers of materials or services related to the Contest, and all of the Town’s elected and appointed officials, employees, agents, representatives, successors and assigns (collectively, the “**Sponsor**”) from any and all loss, harm, claims, cost, expense (including legal and other professional expenses), demands, damages, actions or causes of action whatsoever which I, my heirs, executors or administrators may now or hereafter have against them or any of them in respect of or relating to participation in the Contest, participation in any contest-related activity or the acceptance, use or misuse of the Prize. I agree to look to the manufacturer, supplier or originator, as the case may be, of the Prize and not to the Sponsor for any warranty or guarantee of the Prize or for any damages arising out of my acceptance or use of the Prize;
- (c) grant to the Sponsor the unrestricted right, in the Sponsor’s discretion, to produce, reproduce, publish, broadcast, communicate in any manner, exhibit, distribute, adapt and otherwise use or re-use my entry submission (photograph), name, photograph, likeness and voice in any and all media now known or hereafter devised, in connection with the Contest and the promotion thereof, if so required, without compensation, notice or other

liability to me or my heirs, executors, administrators, personal representatives or assigns; and,

(d) declare that:

- (i) I am eligible to participate in the Contest, have complied with, and will comply with, all the rules and regulations of the Contest, and have answered the skill-testing question below in the manner prescribed;
- (ii) I am a resident of, or a business owner in, the Town of Whitby and have reached the age of majority. Neither I, nor any member of my household or immediate family (includes spouse, mother, father, sister, brother, daughter and/or son, whether or not they reside in the same household), nor any person with whom I am domiciled, is employed by the Sponsor, its advertising and promotional agencies or any of the parties engaged in the development, production or distribution of materials relating to this Contest;
- (iii) the terms of the Contest rules and this Release shall apply to and be binding on me and my heirs, executors, administrators, personal representatives and assigns;
- (iv) this Declaration is, to the best of my knowledge and belief, a true and accurate statement of the facts contained herein; and
- (v) by signing this Declaration, I acknowledge having read, understood and agreed to be bound to the Contest rules and the above Release.
