

THE CORPORATION OF THE TOWN OF WHITBY  
BY-LAW NO. 6348-10

BEING A BY-LAW TO AMEND MUNICIPAL PARKING LOT BY-LAW  
NO. 4910-01, AS AMENDED

---

WHEREAS, Subsection 11(3) of the Municipal Act, 2001, S.O. 2001, c.25, as amended, provides that a lower-tier municipality may pass by-laws respecting municipal parking lots;

AND WHEREAS, the Council of the Corporation of the Town of Whitby has passed By-law No. 4910-01 to establish municipal parking lots on certain lands owned by the town of Whitby and to regulate the parking of vehicles on such lands;

AND WHEREAS, the Council of the Corporation of the Town of Whitby considers it desirable to amend By-law No. 4901-01, to include the municipal parking lot in Brooklin;

NOW THEREFORE, the Council of the Corporation of the Town of Whitby enacts as follows:

GENERAL

- 1) Schedule "C" to By-law No. 4910-01 is amended by adding the following paragraph after the last paragraph in the schedule:

By-Law 6348-10 (Continued)

“LOT 9 – BETWEEN 4 CASSELS ROAD WEST AND VIPOND ROAD, BROOKLIN ALL AND SINGULAR that certain parcels or tracts of land and premises, situate, lying, and being in the Town of Whitby, in the Regional Municipality of Durham, and being composed of PT S1/2 LT 24 CON 6, PTS 1 & 3, PL 40R24505; WHITBY, REGIONAL MUNICIPALITY OF DURHAM, S/T EASEMENT OVER PT 1, PL 40R24504, IN FAVOUR OF PT LT 24, CON 6, PT 2, PL 40R24505 AS IN DR693629 AND PT PRICE ST PL H50052 TOWNSHIP OF WHITBY AS CLOSED BY CO124625; PT S ½ LT 24 CON 6 TOWNSHIP OF WHITBY AS IN CO193234; WHITBY

- 2) Schedule “E” shall be added to By-law 4901 as attached hereto and identified as Schedule “E” to this by-law.
- 3) Section 3.(1) of by-law 4901-01 as amended is deleted in its entirety and replaced by the following:

“3.(1) The lands shown on Schedules “A”, “B”, and “E”, attached hereto, as more specifically described in Schedule “C”, attached hereto, are established as municipal parking lots.”
- 4) Section 6.(1) of by-law 4901-01 as amended is deleted in its entirety and replaced by the following:

“6.(1) Any person who contravenes any of the provisions of this by-law is guilty of an offence and upon conviction is liable to a fine as set out in Section 61 of the Provincial Offences Act R.S.O., 1990 c.P. 33 as amended.
- 5) Section 6.(3) of by-law 4901-01 as amended is deleted in its entirety.

By-law No. 6348-10 (Continued)

EFFECTIVE DATE

- 6) The provisions of this by-law shall come into force and take effect when the ticket machines controlling Lot 9 as described in Section 2 of this By-law have been installed and the signs regulating the use of the lot are in place.
