A. Conform to Tables 1 and 2 of the NRC’s Display Fireworks Manual for Spectator Distance, Fall-Out Zone, and Wind Speed

B. Ramp **not permitted** within

- 300 metres of a storage area containing materials that are flammable, explosive and/or toxic,
- Within 300 metres of institutional buildings such as a hospital or nursing home,
- Within 100 metres of motor vehicles.

WIND SPEED

Maximum surface wind speed for discharging fireworks is not to exceed 40 km/hour.

APPLICANT TO PROVIDE A DESCRIPTION OF:

- THE TYPE OF FIREWORKS TO BE DISCHARGED
- THE DISCHARGE TECHNIQUES TO BE USED
- THE MEANS OF RESTRAINING PEOPLE FROM ATTENDING TOO NEAR THE DISCHARGE LOCATION
- THE MANNER OF DISPOSAL OF UNUSED FIREWORKS
- THE NUMBER OF PEOPLE WHO WILL DISCHARGE FIREWORKS
