BY-LAW NO. 5947-07

GROUP HOME LICENSING BY-LAW

WHEREAS s. 163 of the *Municipal Act*, 2001, S.O. 2001, c. 25, as amended, authorizes the Council of a local municipality to pass by-laws providing for the licensing and annual renewal of licenses of group homes;

NOW THEREFORE the Council of the Corporation of the Town of Whitby hereby enacts as follows:

1. In this By-law:
 - (a) "Group Home" means a residence licensed or funded under a federal or provincial statute for the accommodation of three to ten persons, exclusive of staff, living under supervision in a single housekeeping unit and who, by reason of their emotional, mental, social or physical condition or legal status, require a group living arrangement for their well being. A group home shall not include a crisis residence, a boarding or lodging house, a nursing home, a home for the aged or a retirement home.
 - (b) "Person" includes a natural individual and their heirs, executors, administrators or other legally appointed representatives, a corporation, partnership or other form of business association.
 - (c) "Registrar" means the person designated by Council as the registrar of group homes.
 - (d) "Town" means The Corporation of the Town of Whitby and includes all areas within its territorial limits.
2. The Clerk of the Town of Whitby , and/or his designate, is hereby designated as the Registrar of group homes.
3. No Person shall operate a Group Home that is not licensed in accordance with this By-law.
4. No Person having an interest in land or in premises shall permit the operation on that land or in those premises of a Group Home that is not licensed in accordance with this By-law.

5. Licensing of a Group Home shall be required on an annual basis.
6. The Registrar is authorized to license and to renew the license of a Group Home upon receipt of an application duly completed in the form from time to time prescribed by the Registrar together with the payment of a \$125.00 fee which fee may be amended from time to time by way of and set out in another by-law.
7. The Registrar shall maintain a record respecting each Group Home in respect of which an application for licensing has been made including:
 - (a) the name of each applicant for licensing;
 - (b) the municipal address of the premises in which the Group Home operates or is proposed to operate;
 - (c) the date on which the Group Home use commenced or is proposed to commence;
 - (d) the date of application for licensing;
 - (e) if applicable, the date of licensing;
 - (f) if applicable, the Group Home's status as a Correctional Group Home; and
 - (g) if applicable, the date of refusal for licensing and a brief summary of the reason(s) for refusal.
8. Licensing pursuant to this By-law neither confirms nor relieves any Person from compliance with all applicable law including, without limitation the Town's Zoning By-laws.
9. Each Person who contravenes any provision of this By-law is guilty of an offence and upon conviction is liable to a fine or penalty for each offence, exclusive of costs, as prescribed by the *Provincial Offences Act*, R.S.O. 1990, as amended from time to time.
10. This By-law applies to all lands and premises within the Town.
11. References in this By-law to legislation, including regulations and municipal by-laws, shall include such legislation as from time to time amended including successor legislation.
12. In the event that any provision of this By-law is deemed invalid or void, in whole or in part, by any Court of competent jurisdiction, the remaining provisions shall remain in full force and effect.

SHORT TITLE

13. The short title of this By-law shall be the "Group Home Licensing Bylaw".

REPEAL OF EXISTING BY-LAW

14. By-law No. 5835-06 is repealed.

EFFECTIVE DATE

15. The provisions of this by-law shall come into force and take effect on the day of the final passing thereof.
