1. General Inquiry: 905-430-4907 – By-law Services.
2. Licence Fee: \$62.50. Payment received by **cash, cheque, or debit only**.
3. A Taxi Driver's Licence can only be issued to the applicant.
4. Complete Part 1 of the attached form.
5. Part 2 must be completed by the owner of the taxi company (Bell Taxi or Circle Taxi).
6. The following documents must be returned with the application:
  - a. 2 recent passport size photos
  - b. Valid G Class Driver's Licence
  - c. 3 Year Uncertified Driver's Record - no more than 6 demerit points
  - d. Police Reference Check, including a Vulnerable Sector Screening check (available from your local Police Department)
7. A Taxi Driver's Licence is valid for 1 year.
8. Please note, the processing of applications may take up to 5 business days in total.
