
## Pool Location

Please indicate the distance from the water's edge of the pool to the fence (in all directions). The minimum setback between the water's edge and the fence is 1m. Also, please be sure to indicate the location of any gate(s) and the type of fence (i.e. chain link, board fencing or wrought iron) on each side of the pool enclosure.

## Application Acknowledgements

## Payment Information

- Permit Fee in the amount of \$485.00 made payable to the Town of Whitby. (In case of permit application cancellation by the applicant, only 40% of the permit fee will be refunded).
- If a pool is constructed prior to obtaining a pool enclosure permit, a violation fee of \$648.00 will be charged instead of the standard pool enclosure permit fee.
- Payments:
  - In person: payment can be made at 3050 Garden Street, Unit 102, by debit, cash or cheque.
  - By mail: the completed application and cheque(s) to Enforcement Services, 3050 Garden Street, Unit 102, Whitby, ON L1R 2G7.

## Pool Enclosure Permit Application Process

- Submit your completed Pool Enclosure Permit Application along with the applicable fee and required approvals (if applicable).
- Within 5-7 business days, an Enforcement Officer will review your application and contact you to schedule a pre-construction inspection. **Do not start pool construction until you have been emailed your Pool Enclosure Permit.**
- Once you receive your Pool Enclosure Permit, you can start pool construction.
- When construction is completed, contact the assigned Officer to arrange for a final inspection prior to filling your pool with water.
- After the final inspection is completed and approved, you may fill your pool with water.
